AEO includes exporters, importers, suppliers, customs agents etc.

Facilitate several benefits to the business carrying International trade.

AEO program is purely an **optional** program

It is valid at all customs stations in India

Secure supply chain from point of export to import.

**BENEFITS** 

Border clearance privileges with partner countries in Mutual Recognition Agreement (MRA)

> Customs Assistance for Businesses having trade issues

Reduced disruption of flow other than

security disruption

### **Authorised Economic Operator**

### **Eligibility Criteria:**

Handled 25 documents (SB/BOE) in the last financial year

> Be a part of international supply chain

Can be issued only to individual legal entity and not to group company ഫ 222 



Company's Establishment in India


> Entity should be involved in customs related works.

Highest Level of Facilitation as compared to AEO T1 & T2

Container will not be scanned. If scanned, will be given top priority

Not required to furnish any bank guarantee except when competent authority orders for provisional release of goods. Onsite inspection / examination will be provided on request


> Refund/Rebate of duties and taxes would be granted within 30 days of submission

### **STATUS HOLDER CERTIFICATION**




#### **Objective**

- Objective Recognize exporters as Business leaders who has excelled in trade and contributed towards country's foreign trade.
- Any business holding IEC is eligible for this certification.
- Notified export performance for current and 3 preceding financial years

Status Category	Export performance threshold in USD million
One star export house	3
Two-star export house	15
Three-star export house	50
Four-star export house	200
Five-star export house	800



### **STATUS HOLDER CERTIFICATION**



### **Privileges of Status Holder**

- Authorisation and customs clearance will be given on self-declaration basis.
- Input Output norms will be fixed on priority within 60 days by norms committee.
- Entitled for preferential treatment and priority on clearing the goods.
- Status holders are eligible to export freely exportable items on free of cost goods basis for export promotion subject to an annual limit of Rs. 1 crore or 2% of average annual export realization during the preceding three licensing years, whichever is higher.
